based on a sliding scale system as stipulated in the University Rules and Regulations.

The standard for the rate of increase is based on the slide rate (the rate of increase of the salary of national government employees as announced in the National Personnel Authority's annual salary recommendations in the previous year, etc.).

• The admission fee and the Keio Student Health Care Mutual Aid Association registration fee (100 yen), which is included in other fees, are only collected in the first year and are not included in the total academic fees for current students.

The above amounts also apply to students who have graduated from a Keio University undergraduate faculty or graduate school.

Academic fees and expenses (excluding the admission fee) and other fees can be paid in two installments at the end of April for the Spring Semester and the end of October for the Fall Semester.

However, part of the other fees is collected as a lump sum in the Spring Semester.

Other fees which are collected by the university on behalf of other organizations may be revised during the course of a student's attendance.

*1 The normal completion period is one year. These fees are for students who remain in the program for a second year (part time for one year).

*2 The normal completion period is one year. These fees are for students who remain in the program for six months in a second year (part time for six

months). In such cases a separate fee of 1,640 yen as other fees will be added for those who remain in the spring semester.
