- •The Admission Fee and the Student Health Care Mutual Aid Association Registration Fee (100 yen), which is included in Other Fees, are only collected in the first year and are not included in the total academic fees for current students.
- •The above amounts also apply to students who have graduated from a Keio University undergraduate faculty or graduate school.
- •Academic Fees and Expenses (excluding the Admission Fee) and Other Fees can be paid in two annual installments at the end of April for the Spring Semester and the end of October for the Fall Semester.

 However, part of the Other Fees is collected as a lump sum in the Spring Semester.
- •Other Fees which are collected by the university on behalf of other organizations may be revised during the course of a student's attendance.
- Student's Professional Indemnity Insurance will be collected once for each year of enrollment; in April for April enrollees (Spring Semester) and October for September enrollees (Fall Semester).
